This transfer petition has been filed by the petitioner-wife under Section 25 of the Code of Civil Procedure, 1908 seeking transfer of HMA No.1106 of 2020, titled as "*Anil Pal v. Pratima Baghel*" pending before the District and Sessions Courts, Additional Principal Judge, Family Court, Faridabad, Haryana to the Family Court, Firozabad, Uttar Pradesh.

As per office report, service of show-cause notice is complete but, the respondent-husband has not entered appearance despite service.
