O R D E R

This petition is filed under Section 25 of the Code of Civil Procedure, 1908, seeking transfer of **RCS HM-Regular Civil Suit No. 210A of 2022** titled as “**Sawan Kumar Singh Vs. Neha Singh**” from the Family Court at Rewa, Madhya Pradesh to the Family Court at Allahabad, Uttar Pradesh.

Notice was issued by this court on 27.01.2023. After the sole respondent was duly served, the matter was listed on two occasions i.e. on 22.02.2023 and 28.02.2023, but no one had put in appearance on his behalf despite service.

No one has put in appearance on behalf of the sole respondent even today.

Having heard learned counsel for the petitioner and having considered the facts and circumstances of the case, we deem it fit and proper to allow this transfer petition. Accordingly, **RCS HM-Regular**

Civil Suit No. 210A of 2022 titled as “**Sawan Kumar Singh Vs. Neha Singh**” is ordered to be transferred from the Family Court at Rewa, Madhya Pradesh to the Family Court at Allahabad, Uttar Pradesh.

The parties shall record their presence before the Transferee Court on 17.04.2023.

Let the record of the case be transferred to the transferee court without delay and intimation be sent to both the courts through e-mail for compliance.

It shall be open to the parties to explore the possibility of an amicable settlement through Mediation before the Transferee Court.

The parties are at liberty to participate in the proceedings either physically or through virtual mode with prior permission of the Transferee Court.

The Transfer Petition is, accordingly, allowed.
