Heard Mr. Jayprakash Bansilal Somani, learned counsel appearing for the petitioner. Also heard Mr. Chetan Jadon, learned counsel for the State of Haryana. The respondent no.2 is represented by Mr. Ajay Marwah, learned counsel.

The bail for the respondent No.2 who has filed the criminal appeal before the High Court was granted by taking note of the fact that the appeal is unlikely to be heard on a near date and the convicted accused has served nearly 4 years 11 months of the 10 years' sentence imposed on him by virtue of the conviction under Section 307, 326 and 506 of the IPC.

Looking at the above, we see no reason to disturb the bail order. The Special Leave Petition is accordingly dismissed.
